- 2) Offerors are required to comply with the current procurement code, HRS, Chapter 103-D, any rules and regulations and policy directives issued with respect to Chapter 103-D and any amendments thereof.
- 3) The furnishing and delivery of one (1) passenger mini-van to the Office of Council Services, County of Maui, will be subject to the Minimum Specifications, Questionnaire, Special Provisions, Offer Form and General Terms & Conditions in this order of priority.
- 4) Offer must include all applicable taxes, except Federal Excise Tax from which the County is exempt, and delivery charges F.O.B. 200 South High Street, Wailuku, freight prepaid.

- 6) Vehicle must be delivered fully fueled, assembled and operational.
