Please let me know if this is okay? If not, can we provide you with a DP cable (3ft) along with the adapter?

Response: Yes, the recommended adapter is okay. Yes, a DP cable (3ft) would be okay.

Response: Electronic signatures are acceptable.

Q #6. **Request for Clarification:** For the electronic copy, how would it be submitted in accordance to Item #4 on Page 3.

Response: The electronic copy can be submitted on a flash drive, jump drive, thumb drive, pen drive, or small portable drive.


Q #7. **Request for Clarification:** When dropping off the three hard copies, will the sealed envelopes be time-stamped immediately upon receipt?
